

The Nimisha Prakash Mhatre Foundation, Prabhadevi, Mumbai has applied for establishment of a medical college at Dr. G. D. Pol Medical College Hospital And Research Centre, Plot 19, Institutional Area, Sector 4, Kharghar, Navi Mumbai. On careful consideration of the proposal, the Government of Maharashtra has decided to issue an essentiality certificate to the applicant for the establishment of a Medical College with 100 Seats.

It is certified that:-

a)	The applicant owns and manages a 450 bedded hospital for functioning with 100 MBBS seats which was established in 2021.
b)	It is desirable to establish a medical college in the public interest;
c)	Establishment of a medical college at Dr. G. D. Pol Medical College, Hospital And Research Centre, Plot 19, Institutional Area, Sector 4, Kharghar, Navi Mumbai is feasible.
d)	Adequate clinical material as per the Medical Council of India norms is available.

It is further certified that in case the applicant fails to create infrastructure for the medical college as per NMC norms and fresh admissions are stopped by the Central Government/ NMC, the State Government shall take over the responsibility of the students already admitted in the College with the permission of the Central Government/ NMC.

e)	The Nimisha Prakash Mhatre Foundation, Prabhadevi, Mumbai owns and possesses 20,000 Sq. M. of land in district Raigad, Maharashtra on which non-agricultural use of land is permitted and a Medical College/Hospital can be established on it.
f)	The building plan of the Hospital and Medical College has been approved by the competent authority, namely, Executive Engineer (Bldg. per), Additional Town Planning Officer, CIDCO, Navi Mumbai designated by the State Government for such purposes on 30.05.2001 and 16.07.2014.
g)	The Hospital and Medical College have been granted Completion Certificate/Building Use Certificate by the competent authority, namely Executive Engineer (Bldg. per), Additional Town Planning Officer, CIDCO, Navi Mumbai, designated by the State Government for such purposes on 16.06.2002 and 24.08.2021.

This Certificate is valid for a period of three years from the date of issue, thereafter it will automatically lapse.


